



Election Integrity in Illinois: FACT SHEET

IEIP Projects: Past, Present, Future



The Illinois Election Integrity Program (IEIP) is a project of Illinois Conservative Union. IEIP is part of the national Election Integrity Network (EIN). We are the nationally-recognized election integrity coalition for Illinois. To date, there are approximately 40 states in the EIN national coalition. IEIP is Illinois' "home base" for election integrity. We're doing serious, substantive work to help ensure honest elections.

- Illinois Election Integrity Program (IEIP): Began in 2012 – over a decade of Election Integrity work. We “fly under the radar” so the Left can’t sabotage our work.
- Partners with Cleta Mitchell’s national Election Integrity Network (EIN), Judicial Watch & other national election integrity organizations.
 - » Share research, tactics, techniques
 - » Partner in lawsuits, file amicus curiae briefs, etc.
- 2017: We cold-called Judicial Watch at their DC offices and convinced them to help Illinois.
- Our partnership with Judicial Watch has resulted in 3 lawsuits against Illinois Board of Elections to date.
 - » 1st lawsuit, won in July 2023, giving us access to Illinois voter rolls.
 - » 2nd lawsuit (now in Federal court) to force the state to remove approx. 800,000 ineligible voters from Illinois voter rolls.
 - » 3rd lawsuit, we assisted with the Bost case. Now at SCOTUS, should determine the issue of “standing”. Goal is to end current Illinois practice of counting ballots for 14 days AFTER Election Day.
- Our **Stop RCV Coalition** defeated three Ranked Choice Voting bills during the last two IL Legislative sessions. We partner with national organizations such as AMAC (Assoc. of Mature American Citizens) to issue Action Alerts, resulting in thousands of calls and emails to IL legislators.
- We issue Action Alerts for both State and Federal legislation so citizens can take action on key election integrity issues.
- Over the past decade we’ve trained over 4,000 people in Illinois with our “Guardians of the Vote” program to be election watchdogs, poll workers, poll watchers.
- Working with IL GOP we validate, recruit, train and deploy Election Judges and Poll Watchers.
- We send pre-election mailings to assisted living/nursing homes. We’ve mailed thousands of Statutory Notice letters along with Employee Notice Posters over the past 3 Federal Election cycles (2020, 2022, 2024) to group home Administrators throughout Illinois.
 - » We are the only organization in IL with such a program, putting the Admins of these facilities on notice that we are watching their facility for potential fraudulent activity.
 - » We are the only organization in Illinois working to protect the voting rights of the most vulnerable Illinois citizens.
- Active IL Voter List Maintenance Working Group with top data professionals volunteering their time. (See details of this program on side 2 of this Fact Sheet).
- Expanding our ongoing “Legal Alerts” to all Election Authorities in Illinois, advising them of Federal & state election statutes and explaining their legal obligations. Many of our Election Officials don’t know the law!
- “Carrots & sticks” – extending kudos to Election Authorities which are following the law, while publicly admonishing those who don’t.
- Letters & texts to voters who have moved, with instructions on how to remove themselves from the rolls. (PA did this recently & succeeded in removing 28,000+ voters from PA rolls. Voters thanked them!).
- Work with faith-based “Networking the Networks”, helping pastors & church leaders in IL to get church-goers more civically engaged.
 - » Informing pastors that the Johnson Amendment is null and void– they have free speech in their pulpits!
 - » Training pastors & lay leaders how to legally collect ballots & get more church-goers to VOTE.
- Our national Election Integrity Network was instrumental in working with U.S. Congress to pass the S.A.V.E. (Safeguarding American Voter Eligibility) Act in April of this year.
- Informing & training County Clerks how to use the DHS SAVE (Systematic Alien Verification for Entitlements) database to help them determine if non-citizens are on their county voter rolls.
- We work closely with key people in the Trump Administration and in Congress on Election Integrity issues, lawsuits, and legislation.

IEIP Voter List Maintenance Working Group

The foundational elements for honest elections are clean, accurate voter registrations and clean, well-maintained voter rolls. Our VLM WG works in partnership with the 40+ states in the EIN national network. Those 40 state coalitions share and compare data using a high-level relational database named ELLY. ELLY is the result of the collaboration of some of the top data experts in the nation. This is a list of ELLY data sources:

1. Voter list data from the Secretary of States
2. Voter history data from the Secretary of States
3. Corporate data from the Secretary of States
4. Property zoning codes, property class codes, land use codes from most US Counties
5. Property tax data, homestead exemption status, sale dates & amounts from most US Counties
6. Property description with number of rooms, bedrooms, and owner occupancy from most US Counties
7. Registration Address format corrections from the USPS Coding Accuracy Support System (CASS)
8. Registration Address Type
9. Registration Address information corrections from the USPS CASS
10. Non-Residential Address data from the USPS CASS
11. Mailing Address format corrections from the USPS CASS
12. Mailing Address information corrections from the USPS CASS
13. Non-Deliverable As Addressed data from the USPS CASS
14. Obituary data from funeral homes, newspapers, proprietary sources, & SSA Master Death List
15. Felon data from the states via ORR
16. National Change of Address data from the USPS (48 month)
17. Proprietary Change of Address (PCOA) multi-source, collaborated data (60 month)
18. Proprietary Corporate data from Google® Business
19. Proprietary Maps, street and sky view images from Google®
20. Proprietary Maps, images and text from Zillow®
21. Proprietary Emails and Cell Phone Numbers from multi-source, collaborated data

Our Judicial Watch lawsuits are the “top-down” strategy for cleaning the voter rolls, and our VLM WG is our “bottom-up” strategy for cleaning the rolls. Our calm, professional and authoritative volunteers build relationships with their County Clerk/Election Authority. As each state in the network feeds our updated voter roll data into the ELLY relational database, our volunteers accurately document which voters have moved, what state they have moved to, if they’ve registered to vote in their new state, if they’ve voted. We can present irrefutable evidence to our own County Clerks to remove those voters. The same goes for those on the rolls who are deceased, duplicate registrations, non-citizens, etc.
